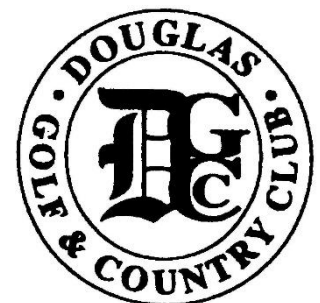

Membership Categories

Social Membership

Our social membership category is for anyone between the ages of 33 and 64. This membership cost is \$225 a month plus a \$50 monthly food minimum and a \$35 monthly capital fund fee. There is also a one-time initiation fee of \$2500.
(\$35 for 18 holes)

JR/Widow/Clergy/SR Membership

Our JR/Widow/Clergy/SR membership is for anyone who is a widow, member of clergy, 32 years of age or less, and anyone 65 years of age and older. This Membership cost \$150 plus a \$50 monthly food minimum and a \$35 capital fund fee. There is also a one-time initiation fee of \$2500.
(\$35 for 18 holes)

Associate Membership

Our associate membership is for anyone that doesn't live in coffee county. This membership is \$125 a month with a \$35 monthly capital fund fee and no food minimum. There is also a one-time initiation fee of \$2500.
(\$35 for 18 holes)

Corporate Membership

Our corporate membership is for any company or organization that would like to offer membership to its employees. There must be a minimum of 3 people to use this membership category. This membership is \$191.25 plus a \$50 food minimum and a \$35 capital fund monthly fee. There is also a one-time initiation fee of \$2500.

Membership Add Ons

Golf Plan

The golf plan is a \$75 monthly add on to your membership dues. With this plan, your 18-hole playing fee will go from \$35 to \$18.

Trail Plan

The trail plan is the \$75 monthly golf plan fee (above) plus a \$133 trail plan fee for a total of \$198. With this add on, your golf is unlimited. You can play as much as you like at no additional charge.
(This membership does not entitle you to a single cart by yourself. Double up cart rules still apply)

Range Plan

The range plan is a \$34 monthly add on that gives you access to unlimited range balls.
